Finance and Fundraising Report Ms. Anne Ortiz, Finance and Resource Director presented the January financial dashboard and reported \$202,000 in the reserve account; the budget is running well but will require revision to accurately present the budget to the Annual Financial Report for the year. The financial framework elements of the dashboard were reviewed with the board as well as the potential outcomes on not meeting financial framework elements. Lastly, the school received a \$4,000 grant from the Dairy Council and Fuel Up to Play 60 for health and physical wellness activities to be implemented.
