The conclusion of the fiscal year includes many adjusting entries so a dashboard for June has not yet been completed and will be presented with more final financial statements in August. The school received substantial approval by the Specialist on the CSI Low Grad Rate Grant for fiscal year 2021. The operating bank account ended the fiscal year with approximately \$320,000 and the reserve account ended with approximately \$150,000. | |
