Finance Report Ms. Anne Ortiz, Finance and Resource Director presented on the financial dashboard for the month of October; Current cash in the operating account exceeds \$88,000. Budgeted expenses are on track; a very balanced month. State aid payment will decrease in November, as they catch-up on overpayment of August, September and October. The month of November will be lean and funds from payroll protection plan will provide stability. Administrator's Update Mr. Rob Pecharich, District Principal, informed the Board of the upcoming visit by the Arizona department of Education via Zoom.
