	Finance Report Ms. Anne Ortiz, Finance and Resource Director presented on the financial dashboard for the month of September; Current cash in the operating account exceeds \$164,000. Budgeted expenses are on track; a very balanced month. State aide payment will decrease in November, as they catch-up on overpayment of August, September and October. The month of November will be lean and funds from payroll protection plan will provide stability. Enrollment stability grant application is ongoing, award letter received in October 2020.	
	Administrator's Update Mr. Rob Pecharich, District Principal, informed the board that 100% online was the right thing to do and some staff are now working two (2) or more days in the building; mitigation practices are followed.	
	Mr. Dave Thatcher, Northwest School Principal, shared that attendance looked good on the first day back from Fall break; Afternoon students, new to Edge, continue to be more successful that returning students. Mr. Thatcher also shared that staff members voiced their concerns about returning to the building and starting hybrid model.
