	Fundraising Report Ms. Anne Ortiz, Finance and Resource Director reported that Edge is not actively fundraising for tax credit, but tax credit season is here and we are seeing an increase in donations, up by \$2,000 compared to the previous year.	
	Finance Report Ms. Anne Ortiz, Finance and Resource Director presented on the financial dashboard for the month of March; Ending cash is over \$16,000. Distance learning reduction of 5% less is equal to \$30,000; ESSER2 not submitted yet; Allocation of \$230,000 will be used on immediate need of pandemic purchases of sneeze guards, partitions, fans and air purifiers and remaining will be used in future fiscal years.	
	Administrator's Update Mr. Rob Pecharich, District Principal, BinaxNOW 15 minute rapid antigen COVID-19 test will be available at Edge Himmel Park and 3 staff members to be trained; the goal is to test symptomatic students on site and know, immediately, if quarantine is required; Mr. Pecharich also shared with board that April will be a busy month, as all school are required to administer state tests in person and on campus to 10 th and 11 th grade students; Kathy Hoffman, Superintendent of Public Instruction has been a true advocate; Ms. Hoffman listens, reaches out and follows up via phone with Mr. Pecharich; Charter School Capital, enrollment marketing partners, are planning to print welcoming signs and provide cookies for onsite students on each campus.
